Thanks to generous donations from the public, we were able to give \$26,427 in subsidies to low-income households using our Heroes Fund grant which helped 356 dogs/cats receive affordable, high-quality spay/neuter and vaccine services. In addition to that internal grant, we were also able to lower the cost of care for feral/community cats by \$2,253, in turn helping 68 cats who may not ever receive medical attention from a veterinarian again. Another exciting way in which we helped the community was a one day event that provided free neuter surgeries for 150 cats, saving those pet owners a total of \$10,500. We look forward to increasing our funding for these programs in the following years.
